

Information pursuant to legislative decree no. 196/2003
(personal data protection Code)

Pursuant to art. 13 of legislative decree no. 196/2003 “personal data protection code” (hereafter referred to as the Privacy code), we hereby inform you that personal data given by yourself by means of on line submission or email contact, will be processed on papery, information or telecommunication supports by Open Sky s.r.l. in full compliance of the above mentioned Code.

Purpose of treatment

Data will be processed in a way to guarantee their safety and privacy in order to :

- a) establish and manage the contractual relationship and the account
- b) to fulfil the legal, the administrative and accounting obligations (management/processing of purchase orders, correspondence, invoicing, etc.) associated with the contractual relationships
- c) carry out technical assistance of the services
- d) manage any claim or complaint
- e) set customized profiles and services

We inform you that providing the data is a mandatory requirement to achieve the contractual and legal obligations. Any refusal to provide the data requested or providing incorrect data could entail the non-execution or partial execution of the duties entrusted to the Company and/or the impossibility of continuing the relationship.

The data will be accessible to:

- subjects, public or private having access to the data by virtue of laws, regulations or EU rules within the envisaged limits;
- subjects requiring access to your data for purposes ancillary to the contractual relationships within the limits strictly necessities to fulfill the purpose.

Your personal data may be disclosed to:

- professionals and consultants, within the limits required to carry out their mandate at our premises, provided we have issued a letter of assignment imposing the duty to treat your data as confidential and reserved;
- other subjects that contribute to the service such as independent service companies (like Internet Service Providers)

Data subject's rights

In accordance with the provisions envisaged under Article 7 of Legislative Decree No. 196/03, the corresponding text of which is provided in full in the paragraph below, the Contractor can write to Open sky to assert his rights.

Right to access personal date and other rights:

1. The data subject shall have the right to obtain confirmation as to whether or not personal data concerning him/her exists, regardless of their being already recorded, and the communication of such data in an intelligible form;
2. The data subject shall have the right to be informed:

- (a) of the source of the personal data;
- (b) of the purposes and methods of the processing;
- (c) of the logic applied to the processing, if the processing is carried out with the help of electronic means;
- (d) of the identification data concerning the data controller, data processors and the representative designated as per Article 5, paragraph 2;
- (e) of the entities or categories of entity to whom or which the personal data may be communicated or who or which may get to know said data in their capacity as the designated representative in the State’s territory, data processors or persons in charge of the processing

3. The data subject shall have the right to obtain:

- (a) updating, ratification or where interested therein, integration of the data;
- (b) erasure, anonymisation or blocking of data that have been processed unlawfully, including data whose retention is unnecessary to the purposes for which they have been collected or subsequently processed;
- (c) certification to the effect that the operations as per sub-sections a) and b) have been notified, as also related to their contents, to the entities to whom or which the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to be protected.

4. The data subject has the right to object, in whole or in part:

- (a) on legitimate grounds, to the processing of personal data concerning him/her, even though they are relevant to the purpose of the collection;
- (b) to the processing of personal data concerning him/her, where it is carried out for the purpose of sending advertising materials or direct selling or else for the performance of market or commercial communication surveys.”
